REQUIREMENTS

To access the hosted Export application, the following components are required:

- Port 3389 must be opened on your company's firewall.
- Windows Remote Desktop Connection (RDP) configured to access: tsx.farrow.com
- The settings for this connection can be provided by Farrow in the form of a customized icon. Otherwise, instructions can be provided to help you set up your own connection.
